Sautéed Crab (Crab Meat with Natural Juices, Crab Stock), Salt, Sugar, Sweet Dairy Whey, Palm Oil, Corn Starch, Natural and Artificial Flavoring, Modified Corn Starch, Hydrolyzed Corn Protein, Soybean Oil, Onion Powder, Disodium Inosinate, Disodium Guanylate, Autolyzed Yeast Extract, Soy Lecithin, Garlic Powder, Paprika.
