#### PHYSICAL DESCRIPTION:

An off-white to slightly yellow seasoning blend with many black, tan and red particulates throughout. This seasoning blend has a mild lemon aroma with a very peppery flavor and heat with a savory citrus lemon note.

#### **USAGE:**

Sprinkle on fish, chicken or seafood prior to cooking.

#### **INGREDIENT STATEMENT:**

Maltodextrin, Spice, Dehydrated Onion, Dehydrated Garlic, Dehydrated Lemon Peel, Citric Acid, Dehydrated Red Bell Peppers, Turmeric, Lemon Oil, less than 2% Silicon Dioxide added to prevent caking.
