PRODUCT DESCRIPTION

A free-flowing light-yellow gravy powder with a savory aroma and flavor. This gravy mix is low sodium.

INGREDIENTS^

Modified Corn Starch, Dehydrated Potatoes, Maltodextrin, Pea Starch, Hydrolyzed Corn Protein, Chicken Broth, Cooked Chicken, Salt, Yeast Extract, Onion Powder, Carrot Powder, Sugar, Chicken Fat, Natural Chicken Flavor, Garlic Powder, Disodium Inosinate, Disodium Guanylate, Natural Flavor, Spices, Turmeric.

APPLICATION

To make one gallon of gravy: Add one bag (13 oz.) of NSLP Chicken Gravy Mix to one-quart cool water. Whip to form a slurry. Add slurry to 3 quarts boiling water. Stir while gravy sets up. Finished gravy may thicken in steam table from evaporation. If necessary, add water to thin.
